- The scholarship amount may vary from year-to-year.
- The applicant must be a high school graduate of a school within the counties of Dauphin, Cumberland, Perry and Northumberland, Pennsylvania at the time of his or her selection to receive award.

### Required Documentation

- ☐ A typed essay, not to exceed 500 words, that includes information about the student's educational and career aspirations, accomplishments and interests.
- ☐ A minimum of two (2) signed letters of recommendation, on school letterhead, from members of the faculty and/or administration.
- ☐ Official SAT or other college-bound test results, if not included in official transcript.

The Scholarship Committee may, but need not in any given scenario, consider the following:

- ☐ The character of the applicant (as determined from the applicant's essay and letters of recommendation).
- ☐ The scholastic record of the applicant.
- ☐ The achievements and goals of the applicant.
- ☐ Financial need.
- ☐ Field of study.
- ☐ Other criteria as set forth in the terms of the document.
